Allegation Management

This half day course is mainly for head teachers, chairs of governors and senior staff with related responsibilities.

This course will give participants an understanding of their roles and responsibilities with regard to the handling of allegations about staff conduct, the role of the Local Authority Allegations Manager and safer working practices. The Allegations Manager (LADO), together with a representative from HR normally attend to comment and advise on current practice.

Chairs of governors are very welcome. They will have to follow this process should their head teacher be the subject of an allegation.

Safeguarding Awareness Training for all staff in education settings

All staff in schools must access a Safeguarding Awareness Raising session at least once every three years. This course is for all staff and is held within the school or college setting. It is usually a two hour session and may be held on a teacher day or after school or a series of sessions can be arranged to flexibly meet the needs of all staff.

Our team of very experienced trainers can be booked to deliver this at a sessional charge of £200.

Experienced DSLs will be given this resource on their training to enable them to deliver this course in-house. These training sessions will be accredited by the local authority.

Part of the role of the DSL is to ensure that all school staff access appropriate, updated safeguarding training. Resources to deliver this will be presented and given to the course attendees.
